INSTRUCTIONS FOR SUBMISSION OF APPLICATION FOR DUAL NATIONALITY CERTIFICATE

General information

A complete set of application for dual nationality certificate consists of i) Application form (pages 1-2), ii) Declaration of Assets (page-3), iii) Statement of Activities (page-4) and iv) Affidavit (page-5). Application and all other required documents have to be submitted in **three complete sets**. Incomplete application may result in delay in the processing of the case.

What to submit:

1. Completed Dual Nationality Application Form (**page 1-2**)
2. Declaration of Assets (movable / immovable) in Bangladesh (**page 4**). Additional pages may be used if required. If the applicant does not have any asset in his/ her name, statement of parents' assets should be provided. In case of application by children, the Declaration of Assets should be that of the parents.
3. Statement of activities in the past 5 years (education, profession, business etc) (**page-5**)
4. Affidavit affirming the truth of the information furnished in the application (**page-3**). This has to be signed before a Notary Public of the First Secretary / Consul of the Consulate General of Bangladesh in New York. In case of children, the affidavit may be signed by father or mother on behalf of the child.
5. Copy of foreign citizenship certificate (US Naturalization Certificate)
6. Copy of foreign passport (for US passport, first two pages)
7. Copy of Bangladesh passport (pages 1 - 7)
8. Copies of receipts of remittances to Bangladesh in the last 3 years.
9. Four(4) recent passport size color photographs (please print name on the back of the photo)
10. Processing fee of US\$ 38 in the form of money order/ bank draft/ certified check drawn in favor of the Consulate General of Bangladesh, New York. Personal checks and cash are not accepted.
11. In case of children born to Bangladeshi parents in the United States, Please submit birth certificate and copies of parents' previous Bangladesh passports (pages 1-7) or their Dual Nationality Certificates.

Please also note: Three complete sets of the application form and all relevant documents (as specified above) have to be submitted for issuance of dual nationality certificate.
